These petitions coming on for admission this day, the court passed the following:

ORDER

Petitioners' contention is that they were appointed on daily wages under the Public Works Department. They continued to work when suddenly their services were dispensed with.

This matter was taken up in L.P.A. No.247 of 2002 (State of M.P. Vs. Centre of Indian Trade Union, Bhopal and Others), wherein the matter was listed before the Lok Adalat on 22.11.2003 when Bench had passed the following orders;

"In view of the aforesaid, LPA stands disposed of in the following terms :-

(a) The employees of the respondent - Union shall be taken back in service in a phase wise manner within a period of six months.

(b) Employees be conferred the benefit of national continuity so that they are not deprived of their right to be regularized, if and when a scheme is framed by the State Government for that purpose.

(c) Whether the issue arises at any point of time for extending the benefit of promotion or ex-gratia payment of the service, the notional continuity would be counted in favour of the employees. Needless to emphasize, if a scheme is brought into force for grant of pension or ex-gratia payment, there shall be a computation of the period treating it as notional. That would mean or deemed to mean that the qualifying service would not carry financial component alongwith it. It is hereby made clear that both the parties very fairly state that any settlement with regard to framing of pension scheme in future or conferring the benefit of regularization by way of policy decision would confer a justifiable right on them, as warranted in law.

(d) The employees shall withdraw all the cases pending in various (legal forums before they are extended the benefit of appointment.

(e) The employees shall fill up the form given by the State Government, which would not contradict any part of this order. Petitioners' contention is that after their reinstatement since High Court had ensured their notional continuity for the purpose of counting that period as period spent on service except for financial benefits, the respondent - State was obliged to consider their case for regularization in terms of the decision of the Hon'ble Supreme Court in the case of **Secretary, State of Karnataka Vs. Uma Devi, (2006) 4 SCC 1**, but instead of doing so they overlooked the Government Circular dated 16.05.2007 and subsequent circular issued in that behalf but have regulated the services of the petitioners in terms of the G.A.D. Circular dated 07.10.2016.

In the aforesaid backdrop, prayer is made, placing reliance on the decision of Supreme Court in Om Prakash Banerjee Vs. State of West Bengal and Others, (2023 SCC OnLine SC 771), to suggest that since petitioners were entitled to and had put in more than 10 years of service as on the date of consideration in terms of the G.A.D. circular dated 16.05.2007, their cases should have been considered in the light of Uma Devi (supra).

Reliance is also placed on a decision of this Bench in W.P. No.29853/2022 (Irfan Qureshi and Others Vs. State of M.P. and Others) decided on 08.02.2023.

Shri Manas Mani Verma, learned Government Advocate for the State opposes the prayer and submits that petitioners are not entitled to any relief after their services being regulated in terms of G.A.D. Circular

dated 07.10.2016.

After hearing learned counsel for the parties and going through the record, and with a view to maintain parity, it is directed that the respondents will consider the cases of the petitioners within a period of 120 days from the date of receipt of certified copy of this order being passed today in the light of the decision of Supreme Court in **Uma Devi** (**supra**) and the G.A.D. Circulars issued thereafter on 16.05.2007 and also other circulars issued from time to time.

Respondents are also directed to consider the cases of the petitoners as per their seniority after preparing a list of seniority showing the date of initial appointment of each of the workmen including those who have already been regularized. If they are subsequent appointees than the petitioners, then consider each case on the basis of the guidelines laid down by Hon'ble Supreme Court in the case of **Uma Devi (supra)**.

Let this exercise be completed, screening be done and eligible candidates be given their due within the aforesaid period.

Petitions are allowed and disposed of.
